PROJECT OVERVIEW:

Welty Building Company is the awarded general contractor for the Medical Marijuana Processing Facility located at 6913 Dayton-Springfield Road in Enon, Ohio.

The project includes the renovation and conversion of a former hardware store to a medical marijuana processing facility. The building is slab on grade with a wood frame structure, wood trusses, brick veneer and a shingle roof. The building will be single use. The envelope of the building will remain mostly unchanged, with the exception of added doors and infilling windows. The building interior shall be demolished and replaced with new finishes. New plumbing, mechanical and electrical systems are included in this project. There are no fire suppression systems anticipated for this building.

Trades include: selective interior demolition, masonry infill, finish carpentry, blown-in insulation, doors, frames & hardware, flooring, painting, restroom accessories, fire protection specialties, pre-manufactured vault, plumbing, mechanical, electrical, fencing, asphalt repair.

This project is taxable and non-union/open shop.
